ABOUT THE SEMINAR: -

This Seminar commemorates the Centennial Year of the Rashtrasant Tukadoji Maharaj Nagpur University and 70th Year of the Post Graduate Teaching Department of Law.

Criminal law plays a pivotal role in adjusting the legal framework to meet the evolving demands of society, ensuring that justice not only prevails but also aligns with contemporary values. Despite multiple amendments to criminal laws to keep the legal structure in sync with societal shifts, as well as technological advancements and emerging challenges, India has encountered difficulties in delivering timely justice due to cumbersome procedures. An overhaul of the criminal justice system was long overdue to address these prolonged delays and streamline the legal process. A discussion and deliberation on the current overhaul of the Criminal Laws will enable the students and academicians to understand the unknown.

Another aspect of this Seminar is the intersection of crime and technology which refers to the point where criminal activities and technological advancements meet, creating a complex and evolving landscape.



The present seminar shall focus on the new reforms of criminal law as well the advancement of technology in aspects of criminal law, and help in providing a research - based platform for brainstorming and providing ways and means for improvement.

7. Artificial Intelligence and Cyber Crimes
8. Crimes in Metaverse

Any other topic related to the theme of the seminar.

PUBLICATION: -

Selected papers will be published in the form of a book bearing ISBN Number by a Renowned Publisher.

The submitted papers must be the original work of the author and must not be previously published. All papers shall be subject to the approval of the Editorial Board and will be run on a Plagiarism Software.

SUBMISSION GUIDELINES:-

The guidelines for the submission of the paper are as follows:

1. The research papers should pertain to any of the sub-themes of the conference.
2. Participants shall be required to submit an abstract of around 350 words.
3. The abstract shall also contain, the name of the author/authors, email ID of the author's contact number and designation.
4. Acceptance of abstracts shall be communicated separately. The payment link shall be shared separately if the abstract is selected.
5. Full paper shall not exceed 5000 words. It shall be typed in Times New Roman, Font Size 12 on A4 size paper on any of the sub-themes of the conference with 1" margin on all sides with 1.5 line spacing using MS Word.
6. Abstract and papers shall be required to be emailed at pgtd.seminar2024@gmail.com
7. Citation shall be strictly in accordance with Bluebook format.



8. The Department may publish selected papers. Selection of papers for publication shall be the exclusive discretion of the Editorial Board.
9. The submitted papers will be subjected to Plagiarism Check.
10. Co-authorship is permitted up to 2 authors.
11. During submission of Abstract, the email subject should contain "National Seminar – Abstract Submission"
12. During submission of the final paper, the email subject should contain "National Seminar – Final Paper Submission."
